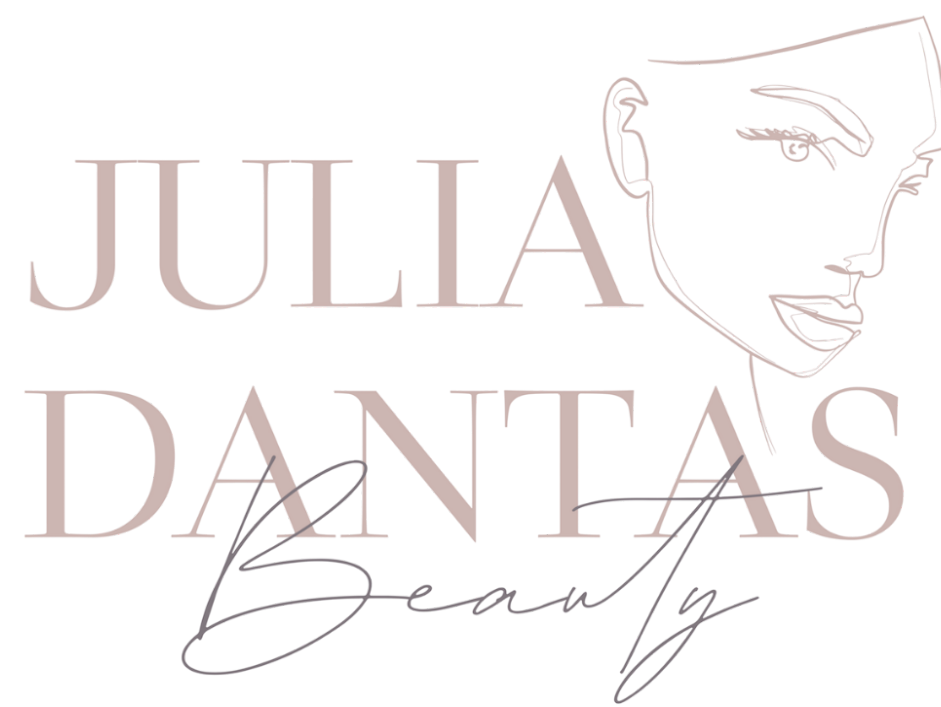


T E R M S A N D C O N D I T I O N S
